 - Goods and Service Tax Registration Numbers;
 - Goods and Service Tax returns acknowledgement numbers for the financial year 2023-24;
 - Income tax return filing acknowledgement number for the assessment year 2024-25;
 - Balance sheet, audit report and directors reports for tile financial year 2023-24 filed with tile Registrar of Companies;
 - Register of direct sellers updated as of March 5, 2025;
 - Certificate of Importer-Exporter code (in case of imported goods);
 - License issued under the Food Safety and Standards Authority of India Act, 2006 (34 of 2006) for the purposes of manufacture or sale of food items;
 - Following licenses issued under the Drugs and Cosmetics Act, 1940 {23 of 1940}-
 - Drugs and Cosmetics Manufacturing License, Naida; and
 - Drugs and Cosmetics Import License.
 - Trademark Certificates;
8. Self-declaration of Oriflame in terms of Rule 5(1)(c);
9. Contact information of Oriflame which is current and updated;
10. Details of Oriflame's nodal officer, grievance redressal officer, its management;
11. Details of Oriflame's products, product information, price;
12. Grievance redressal mechanism for consumers;
13. Correct and complete information at pre-purchase stage to enable buyers to make informed purchase decisions, and such information shall, in addition to the mandatory declarations to be provided under the Legal Metrology (Packaged Commodities) Rules, 2011, contain the following information, namely:-
 - the name of purchaser;

- description of goods or services;
 - quantity of goods or services;
 - the estimated delivery date of goods or services;
 - the process of refund; and
 - exchange or replacement of goods in case of it being defective.
14. Display of the current and updated name, contact details including telephone number, email address and designation of grievance redressal officers on Oriflame website.
15. Record of relevant information allowing for identification of all direct sellers who have been delisted by Oriflame (as of March 5, 2025) and such list has been publicly shared on Oriflame's website.
